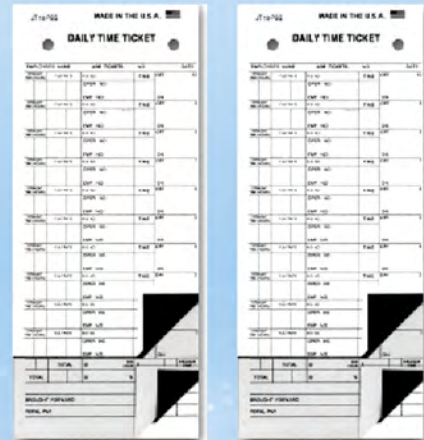

# ARE YOU COMPLIANT?

## BUYERS GUIDE

**IMPORTANT:** Spoken promises are difficult to enforce. Ask the dealer to put all promises in writing. Keep this form.

### WARRANTIES FOR THIS VEHICLE:

**IMPLIED WARRANTIES ONLY**

The dealer doesn't make any promises to fix things that need repair when you buy the vehicle or afterward. But implied warranties under your state's laws may give you some rights to have the dealer take care of serious problems that were not apparent when you bought the vehicle.

**DEALER WARRANTY**

**FULL WARRANTY.**

**LIMITED WARRANTY.** The dealer will pay \_\_\_\_\_ % of the labor and \_\_\_\_\_ % of the parts for covered systems that fail during the warranty period. Ask the dealer for a copy of the warranty, and for any exclusions, coverage, exclusions, and the dealer's repair obligations. Implied warranties under your state's laws may give you additional rights.

**SYSTEMS COVERED:** This vehicle is sold with the statutory warranty required by the state of New York. The systems covered by this warranty include:

(a) Engine. All lubricated parts, water pumps, fuel pumps, fuel injectors, timing belts, timing chains, and flywheels.  
(b) Transmission. The transmission case, housing, and shafts, including the input and output shafts, planetary gear sets, and universal joints.  
(c) Drive Axle. Front and rear drive axle bearings, axle tubes, axle shafts, axle nuts, axles, axleshafts, universal joints, and drive shafts.  
(d) Brake. Master cylinder, system and wheel cylinders, brake lines and fittings, and disc brake calipers.  
(e) Radiator.  
(f) Steering. The steering gear, steering knuckles, tie rods, steering knuckle, valve body, piston and rack.  
(g) Alternator, generator, or the ignition system exciter.  
(h) Other, if any.

**DURATION:**  
90 days or \_\_\_\_\_ miles, whichever is longer.  
90 days or \_\_\_\_\_ miles, whichever is longer, but less than 90,000 miles.  
36 months or \_\_\_\_\_ miles, whichever is longer, but less than 100,000 miles.

If the vehicle is covered by a limited warranty from its manufacturer, this warranty shall be effective for the period of time between the expiration of the manufacturer's warranty and the remaining term of this warranty, if any.

### NON-DEALER WARRANTIES FOR THIS VEHICLE:

**MANUFACTURER'S WARRANTY STILL APPLIES.** The manufacturer's original warranty has not expired on some components of the vehicle.

**MANUFACTURER'S USED VEHICLE WARRANTY APPLIES.**

**OTHER USED VEHICLE WARRANTY APPLIES.**

**SERVICE CONTRACT.** A service contract on this vehicle is available for an extra charge. Ask for details about coverage, deductible, price, and exclusions. If you buy a service contract within 90 days of your purchase of this vehicle, implied warranties under your state's laws may give you additional rights.

**ASK THE DEALER IF YOUR MECHANIC CAN INSPECT THE VEHICLE ON OR OFF THE LOT.**
